CIRCULAR

It is observed that very few candidates are appearing for Fishing Engineer Competency Examination due to lack of proper guidance and insufficient knowledge of the candidates in relevant subjects like Applied Mechanics, Heat Engine, Electro Technology, Engineering Drawing etc. It is understood that the students of CIFNET even after Engine Driver examination are not able to clear the Fishing Engineer Competency Examination conducted by MMD/DG Shipping. Considering the increasing demand of Fishing Engineers onboard the deep sea fishing vessels, it has been decided to conduct a refresher course of 2 months duration to cover the syllabus of Fishing Engineer Examination so that the Engine Driver qualified candidates will be benefitted at large. The refresher course will be conducted at CIFNET Unit, Chennai, which is proposed to be commenced during the second week of November, 2022. Therefore, it is informed that all those candidates who are willing to attend the said refresher course with the eligibility of Engine Driver Fishing Vessel or Marine Fitter Course with 1 year of practical experience on board the vessel may apply for the course to the Deputy Director, CIFNET Unit Chennai. The course fee of Rs.10,000/- will be required to be paid in favour of the PAO, Chennai through Bharat Kosh Portal under the Sub Head "208793-CIFNET-008743-Receipts Course/Training fees" while applying for the course with the details filled in the application (copy enclosed). The dormitory accommodation can be provided at CIFNET Unit hostel, Chennai with a nominal rent of Rs. 1500/- per month. Based on the response received, the course will be conducted in regular batches twice in a year.
