Job description: Engaging class in fishing gear technology and fish capture techniques both theoretical and practical to trainees and assisting the Chief Instructor (FT) in the functioning of craft and gear division. Undertake fishing cruise as shore officer participant alongwith institutional/post-institutional trainees on board the fishing vessel for imparting practical training.
