



COUNSELING CUM ADMISSION NOTIFICATION

Counseling for admission to Vessel Navigator Course(VNC) and Marine Fitter Course (MFC) of 2 years duration for the year 2024-2026 will be held at <u>CIFNET</u>, <u>Fine Arts Avenue</u>, <u>Ernakulam-16 on 18.07.2024 at 0900 hrs</u> with following conditions for the allotment of Training Centre (ie, CIFNET Kochi/ Chennai/ Visakhapatnam). The candidates who are provisionally selected are directed to attend counseling.

- 1. The candidates who are attending counseling have to pay the counselling fee of **Rs. 3025/-**by Demand Draft drawn in favor of "**Pay and Accounts Officer, Kochi**' payable at **Ernakulam-16** which will be adjusted against tuition fee and the Candidates have the option to select the Training Centre (ie, CIFNET Kochi/Chennai/Visakhapatnam) as per the Rank list on the day of Counseling itself. If there is no vacancy in the opted training centre, the second or third option of training centre will be allotted as per the availability of seat.
- 2. The candidates who are attending Counseling are informed to bring Demand Draft of Rs.3025/-, all original certificates, like SSLC/Community certificate (If SC/ST/OBC-NCL/Gen-EWS), Transfer Certificate (TC), Training Centre Allotment Form, Hall Ticket issued by CIFNET for appearing Entrance Examination. However, the Migration certificate for the candidates belonging to other States can be submitted in the respective training centre on the day of joining.
- 3. If a candidate has already been admitted or pursuing a course in an Institution and has deposited all the original certificates in an Institution, a bonafide letter from the Head of the Institution may be produced to that effect. In such case, only copies of certificates attested by Head of the Institution will be accepted. However the original allotment order will be withheld till the original certificates are verified.
- 4. The Candidate has to attend the Counseling at his/her own cost.
- 5. The counseling cum admission notification is only provisional and it will be confirmed only after ascertaining the candidate's suitability/medical fitness. The Institute/ the trainee will have the option to terminate the training at the end of a fishing cruise or within one month of training with full refund of deposit amounts on payment of tuition fee and lodging charges for 6 months, mess charges for the month (s) he attended training, and on effecting recoveries for damage/loss, if any without forfeiting the bond amount and in all cases of discontinuance after one month, only caution deposit will be refunded.
- 6. The merit list candidates selected for Vessel Navigator Course, should produce eye sight test pass certificate as per NEW ENTRY STANDARD regulations prescribed by the Mercantile Marine Department, Ministry of Surface Transport, Government of India, at the time of counseling. For obtaining this certificate he may appear for the test on payment of the prescribed fee, along with identity certificate such as SSLC certificate (with identification marks) or Hall Ticket issued by CIFNET (with photograph), to the Medical Practitioner approved by the Director General of Shipping as per the Rule 4 of M.S (Medical Examination) Rules, 2000. The address of the Medical Practitioners is available in CIFNET offices or in the website https://www.dgshipping.gov.in/.

- 7. Monthly stipend @ Rs.1500/- p.m for 24 months during the training period will be paid by this Institute, on submission of a Surety Bond for Rs.15,000/- (Rupees Fifteen thousand only) within one month after joining for training in the prescribed format (copy of the bond uploaded in CIFNET website) to be typed on stamp paper worth Rs.50/and executed by the candidate's father/guardian as obligator. A fixed deposit for Rs.15,000/the name of obligator should be produced along with the bond. The Surety Bond should be authenticated by affixing the signature of Parent/Guardian (Obligator) at the bottom of each
- 8. He will have to compulsorily reside in the Institute Hostel for which hostel rent of Rs.4800/- annually (subject to revision) will be collected. Boarding expenses will also have to be met by him.
- 9. The candidate has to remit the amounts shown below as per the rules of the Institute.

The unspent amount, if any out of the deposits (ix) to (xii) above will be refunded on completion of the training course. In the case of the candidates discontinuing the training in the middle of the course, either or their own or as a sequel to any disciplinary action they or their Guarantor/ Sponsorer will have to pay the Government the proportionate cost of their training that would be decided by the Director of the Institute, as and when such instances occur.

- 10. If a candidate has already been admitted or pursuing a course in an Institution and has deposited all the original certificates in an Institution, a bonafide letter from the Head of the Institution may be produced to that effect. In such case only, copies of certificates attested by Head of the Institution will be accepted. However the original certificate should be submitted to this office on the day of admission i.e, on or before 07.08.2024.
- 11. Due to unforeseen and unavoidable reasons, if a candidate is unable to attend the counseling on the date and time mentioned above, the candidate cannot claim for admission as a right, as the vacant seat will be filled with the waitlist candidates.
- 12. He should produce a Physical Fitness Certificate from a Govt. Medical Officer to the effect that he is physically fit to undergo strenuous training at sea.
- 13. He should bring all his original certificates in support of age, qualification, experience etc. and in the case of SC/ST/OBC-NCL/Gen-EWS candidates, Community Certificates from Revenue authorities clearly specifying that the candidates belong to SC / ST/OBC-NCL/ Gen-EWS.
- 14. He should abide by the rules and regulations of the Institute with regard to discipline, attendance, uniforms, co-curricular activities etc. Wearing the prescribed uniform is compulsory.

- 15. He should also give an undertaking/ declaration that he will undergo the training at his own risk. Any form of ragging is not allowed in the campus and hostel. Formal declaration by the candidate/parent has to be furnished to the effect that any action as deemed fit will be initiated if the individual is involved in the Ragging.
- 16. Onboard sailing is compulsory during the training period failing which he will not be allowed to continue the course.
