**ADMISSION MEMORANDUM**

The candidates included in the Rank List are informed that he/she has been provisionally selected for the admission into Vessel Navigator Course/ Marine Fitter Course conducted at **Cochin/ Chennai/ Visakhapatnam** as a **MERIT LIST/ WAIT LIST** candidate in **General/General-EWS/OBC-NCL/SC/ST** category.

1. The admission memorandum for the **MERIT LIST CANDIDATES** and **WAIT LIST CANDIDATES** are hereby issued only as provisional subject to the payment of fees and submitting the self attested copies of certificates/required documents. The candidates should report to their nearest CIFNET Centre (Kochi/Chennai/Vizag) on 11-10-2021. The admission will be confirmed only after submitting the original certificates and required documents. However, the admission of wait listed candidates will be confirmed only if any vacancy arises due to the non reporting of merit list candidates on 11.10.2021. The training centre allotment form duly filled may also be submitted.
2. The Institute/ the trainee will have the option to terminate/discontinue the training at the end of a fishing cruise or within one month of training with full refund of deposit amounts on payment of tuition fee and lodging charges for 6 months, mess charges for the month(s) he/she attended training, after deducting the dues for damage/loss, if any without forfeiting the bond amount. If he/she wants to discontinue the course after one month/middle of the course, only caution deposit will be refunded and also will recover the proportionate cost of training or surety amount of Rs. 15,000/- whichever is less from the candidate or Surety.
3. The candidates category of the EWS/OBC-NCL/SC/ST who had not submitted their valid Caste certificates on or before 13.10.2021 will be considered in the General category only.
4. On receipt of the following, the provisional admission will be confirmed on the basis of their merit subject to the seat availability.
  - (a) Rs. 15175/- (Demand draft may be drawn in favour of Sr.Administrative Officer, CIFNET, Kochi payable at Kochi-16)
  - (b) Transfer certificate, Conduct certificate, migration certificate and SSLC/10th certificate with mark list
  - (c) Gen-EWS/OBC-NCL/SC/ST Valid Certificate
  - (d) Sight Test Pass certificate for VNC/Fitness certificate for MFC
  - (e) Age proof (Birth certificate/10<sup>th</sup> Std) if it is not mentioned in SSLC/10<sup>th</sup> certificate
  - (f) Copy of Aadhar card
  - (g) Copy of bank pass book (First page)
5. The candidates have to submit surety bond for Rs.15,000/- ( Rupees Fifteen thousand only) in the prescribed format (copy uploaded in website) within three months from the date of their joining to get the monthly stipend of Rs. 1500/- pm from this Institute for 24 months of training. In case, the candidates fail to submit the surety bond amount of Rs.15,000/- within three months, then the candidates will be entitled for stipend only from the date of submitting the surety bond to the Office. The bond is to be typed on stamp paper worth Rs.50/- and executed by the candidate's father/guardian as obligor and Fixed deposit for Rs.15,000/- in the name of trainee with lien to CIFNET should be submitted along with the bond.

6. The candidates selected for Vessel Navigator Course, should produce eye sight test pass certificate from Government Ophthalmologist/MMD approved doctor.
7. The selected candidates should report to the allotted Training Centre on 13.10.2021.

The candidate has to remit the amounts shown below as per the rules of the Institute.
