COUNSELLING CUM ADMISSION NOTIFICATION

Counselling for admission to Vessel Navigator Course(VNC) and Marine Fitter Course (MFC) of 2 years duration for the year 2026-2028 will be held at **CIFNET, Fine Arts Avenue, Ernakulam-16 on 23.07.2026 at 0900 hrs** with following conditions for the allotment of Training Centre (ie, CIFNET Kochi/ Chennai/ Visakhapatnam). The candidates who are provisionally selected are directed to attend Counselling.

1. The candidates who are attending Counselling have to pay **Rs.1000/-** towards Admission fee (non-refundable) by Demand Draft drawn in favor of **"Pay and Accounts Officer, Kochi"** payable at **Ernakulam-16**. The Candidates have the option to select the Training Centre (ie, CIFNET Kochi/Chennai/Visakhapatnam) as per the Rank list on the day of Counselling itself. If there is no vacancy in the opted training centre, the second or third option of training centre will be allotted to the candidate as per the availability of seat.
2. The candidates who are attending Counselling are informed to bring Demand Draft of Rs.1000/-, all original certificates, like SSLC/Community certificate (If SC/ST/OBC-NCL/Gen-EWS), Transfer Certificate (TC), Training Centre Allotment Form, Hall Ticket issued by CIFNET for appearing Entrance Examination. However, the Migration certificate for the candidates belonging to other States can be submitted in the respective training centre on the date of joining.
3. If a candidate has already been admitted or pursuing a course in an Institution and has deposited all the original certificates in an Institution, a bonafide letter from the Head of the Institution may be produced. In such case, only copies of certificates attested by Head of the Institution will be accepted. However the original allotment order will be withheld till the original certificates are verified.
4. **The Candidate has to attend the Counselling at his/her own cost.**
5. The Counselling cum admission notification is **only provisional** and it will be confirmed only after ascertaining the candidate's suitability/medical fitness.
 - (a) If the trainee discontinues the training before the commencement of classes, the Institute will refund all Fees paid except Admission Fee.
 - (b) If the trainee discontinuing the training before the Admission Closing Date specified by Directorate General of Training, New Delhi or Nodal ITI, the Institute will refund all the deposits paid and Tuition Fees after deducting proportionate amount for the period of study.
 - (c) If the trainee discontinues the training after the Admission Closing Date, the Institute will refund deposits and proportionate Tuition Fees after deducting 6 months tuition fee & lodging charges, mess charges for the month (s) he attended the training, and on effecting recoveries for damage/loss, if any without forfeiting the bond amount.
6. The selected candidates for Vessel Navigator Course, should produce eye sight test pass certificate as per NEW ENTRY STANDARD regulations prescribed by the **Mercantile Marine Department, Ministry of Surface Transport, Government of India**, at the time of Counselling. For obtaining this certificate he may appear for the test on payment of the prescribed fee, along with identity certificate such as 10th certificate (with identification marks) or Hall Ticket issued by CIFNET (with photograph), to the Medical Practitioner approved by the Director General of Shipping as per the Rule 4 of M.S (Medical Examination) Rules, 2000. The address of the Medical Practitioners is available in CIFNET offices or in the website <https://www.dgshipping.gov.in/>.
7. **Monthly stipend @ Rs.1500/- p.m for 24 months during the training period will be paid by this Institute, on submission of a Surety Bond for Rs.15,000/- (Rupees Fifteen thousand only) within one month after joining for training in the prescribed format (copy of the bond uploaded in CIFNET website) to be typed on stamp paper worth Rs.50/- and executed by the**

candidate's father/guardian as obligator. A fixed deposit for Rs.15,000/- the name of obligator should be produced along with the bond. The Surety Bond should be authenticated by affixing the signature of Parent/Guardian (Obligator) at the bottom of each page.

8. **He will have to compulsorily reside in the Institute Hostel for which hostel rent of Rs.4800/- annually** (subject to revision) will be collected. Boarding expenses will also have to be met by him.
9. The candidate has to remit the amounts shown below as per the rules of the Institute.

In addition 1) Mess dues will be payable on monthly basis.

2) Examination fee as per the NCVT norms is payable before the examinations

3) Fee for the second year has to be paid at the beginning of the 2nd year

The unspent amount, if any out of the deposits (ix) to (xii) above will be refunded on completion of the training course.

10. If a candidate has already been admitted or pursuing a course in an Institution and has deposited all the original certificates in an Institution, a bonafide letter from the Head of the Institution may be produced to that effect. In such case only, copies of certificates attested by Head of the Institution will be accepted. However the original certificate should be submitted to this office on the day of admission i.e, on or before **04.08.2026**.
11. Due to unforeseen and unavoidable reasons, if a candidate is unable to attend the Counselling on the date and time mentioned above, the candidate cannot claim for admission as a right, as the vacant seat will be filled with the waitlist candidates.
12. He should produce a Physical Fitness Certificate from a Govt. Medical Officer to the effect that he is physically fit to undergo strenuous training at sea.
13. **He should bring all his original certificates in support of age, qualification, experience etc. and in the case of SC/ ST /OBC-NCL/Gen-EWS candidates, Community Certificates from Revenue authorities clearly specifying that the candidates belong to SC / ST/OBC-NCL/ Gen-EWS.**
14. He should abide by the rules and regulations of the Institute with regard to discipline, attendance, uniforms, co-curricular activities etc. Wearing the prescribed uniform is compulsory.
15. He should also give an undertaking/ declaration that he will undergo the training at his own risk. Any form of ragging is not allowed in the campus and hostel. Formal declaration by the candidate/parent has to be furnished to the effect that any action as deemed fit will be initiated if the individual is involved in the Ragging.
16. Onboard sailing is compulsory during the training period failing which he will not be allowed to continue the course.
17. After receiving the Confirmation of Admission letter from CIFNET on the date of Counselling, the candidates are directed to report at the respective allotted Training Centre (ie, CIFNET, Kochi/Chennai/Visakhapatnam) with the remaining fee & other necessary documents ie, **Director, CIFNET, Fine Arts Avenue, Ernakulam/ Deputy Director, CIFNET Unit, 59, S.N.Chetty Street, Royapuram, Chennai-13/ Deputy Director, CIFNET Unit, Fishing Harbour, Beach Road, Visakhapatnam-1 for admission** and the regular classes will commence on **04.08.2026**.
